Precautions

- Always store the headset with the power off and safely protected.
- Avoid storage at extreme temperatures (above 70°C / 158°F or below -40°C / -40°F). This may adversely affect the headset.
- Avoid using the headset for too long and/or with high volume, this may affect the hearing.

Precauciones

- Evitare di usare la cuffia per troppo tempo e/o a volume alto, questo potrebbe danneggiare l'udito.
